

Justice and Religious Affairs Sector

Key differences between the estimated appropriations for 2024 and the re-estimation for 2023 of the sector :

Current expenditure :

- An amount of (228.117) million JDs was allocated for current expenditures, with an increase of (16.671) million JDs over the re-estimation as follows:
- The allocation of compensation group increased by (11.639) million JDs, to cover the cost of the natural annual increase in employees' salaries and the cost of filling vacant and updated jobs.
- The allocation of the use of goods and services group increased by (2.340) million JDs, the increase concentrated in rents, water, electricity, fuels and cleaning contracts items.
- Increasing the allocation of other expenditures and subsidies by (2.692) million JDs, and the increase concentrated in the allocation of various funds in the sector, especially social solidarity funds.

Capital expenditure :

- An amount of (22.339) million JDs was allocated for capital expenditure, with an increase of (3.661) million JDs over the re-estimation, as the increase was concentrated on the following projects:
- Rehabilitation of the building of the Palace of Justice of Amman to include the complex of the courts of First Instance.
- Construction and equipping of the Amman Court of Appeal building.
- Raising electronic readiness and developing infrastructure for computing projects.
- Improving the efficiency and development of the work of judicial bodies.
- Purchasing a land and constructing a building for the Ministry of Awqaf.
- Governorates councils' projects.
- Development of public Ifta' programs.
